#### 09. Institutional Annual Budget 2015-16

The Institutional Annual Budget 2015-16 summary was presented by Dr Mohanty. He mentioned that there are increases in budget allocations both for MMS & Part-time as well as PGDM.

MANAGING COMM

As far as MMS & Part-time Programmes are concerned, the increase in capital expenditure is mostly due to proposed implementation of ERP solution, development of new interactive website and purchase of both digital books for the e-library as well as physical books (mainly course books).

The increase in operating expenses is mostly in the areas of Advertisement/Promotion/Branding Expenses, Proposed Ph. D. Programme, Students Development Programme and for starting Entrepreneurship & Business Incubation Centre / Consulting Activities. The total operating expenses and capital expenditure is budgeted to be around Rs. 6.3 crore, while the total expected income will be around Rs. 4.6 crore, leaving a deficit of Rs. 1.7 crore.

The PGDM programme supplements the overall Institute's budget and its operating expenses are mostly covered by its income, sometimes, leaving some surplus. The total operating expenses of PGDM has been budgeted at around Rs. 90.14 lakhs, while the income has been estimated around Rs. 89.9 lakhs.

Bro. Tom Melchior questioned that how we are going to finance such increase in the budget, to which Dr Mohanty mentioned that we will try to raise some funds but it will be mostly covered by support from the Society.

#### 10. Students co-curricular and extra-curricular activities

Students participated in various co-curricular and extra-curricular activities, notable among them are as follows:-

- Mumbai University Department of Lifelong Learning and Extension: 160 students participated in 4 projects under the guidance of Prof. Sulbha Raorane, Prof. Kiran Rodrigues and Prof. Renita Dsouza and SFIMAR was adjudged as the Best Participating B-School in Extension and Community Development projects.

#### 08. Fee Fixation:

Fees approved for the next Academic batch by FRA are as follows;

- MMS: 182223 (Tution fees) + 22777 (Development fees) = 205000/-
- Part time (MMM/MFM): 30972 (Tution fees) + 4028 (Development fees) = 35000/-
- PGDM: 156600 (Tution fees) + 10000 (Development fees) = 166600/-

Mr. Albert D'Souza suggested to improve the quality of Part-time programme by putting some more investment in part-time programme. Thus, the fee level will be automatically increase.

- 13. Any other matters:
- a. Under any other matters, Bro. Alphonse informed about the Government directives to shut down schools and colleges. Accordingly, the students were informed to stay at home from 14<sup>th</sup> March 2020, due to Covid-19. Staff are requested to work on alternate days or to work on daily basis with relaxation time till further notice.

The hostel students were given option to go home or to stay in the hostel with the permission of their respective parents and guardians. Out of 82 hostel inmates only 4 of them gave application to stay back in the hostel including one international student from Indonesia.

b. Application of Librarian Ms. Papinder Kaur Nagi was taken up as she requested for reference letter to do her PhD at Guru Nank Dev University Amritsar in Library and Information Science.

Accordingly the EC members approved her request for the same.

c. Application of Ms. Sangeeta Varma, Placement and Training department requesting for additional male staff in her department.

The members felt that the application should be kept pending as the college is shut and it can be taken up when the college open. It is also observed that the intakes are increasing the requirements of additional staff is needed in the future. Proper selection process is recommended.

- d. Quotation was presented to the EC members from Naushad Brother's for painting of external portion of SFIMAR Management building. Rs. 599172 was the quotation after negotiation. The same has been approved.
- e. Other maintenance work, drainage work, roof repair work of assembly hall in consultation with Architect etc. were approved in the meeting.
- f. The application of support staffs were taken up for financial help for their treatment. A house keeping staff Ms. Marjama was given Rs. 25000 medical assistance. And Ms. Chhaya Popat Kamble who met with motor cycle accident was given medical assistance against hospital bills Rs. 35300/=.
